3. HAZARD IDENTIFICATION

The product is safe if used following the instruction provided by the manufacturer both for human health and environment. Consider the following information only in case of accident or misuse. Ingestion may cause gastrointestinal.

4. FIRST AID MEASURE

6. ACCIDENTAL RELEASE MEASURES

7. HANDLING AND STORAGE

Handling

- Follow the instruction on the label, case, leaflet, band or other cards.
